

## Colorado Election Integrity Project: Response to Ken Buck's Livestream on December 2, 2020

We, the people of Colorado, have observed the events that transpired on and after Election Day, not only in the State of Colorado, but throughout the United States of America.

We have seen a preponderance of evidence of impropriety and malfeasance in our electoral systems, both in operation and structure, well beyond reasonable doubt.

As respectful and patriotic citizens, we have remained united and resolved in allowing time for the legislative and judicial processes, as enshrined in the US Constitution, to respond to the allegations and evidence of both widespread and targeted interference and voter fraud in our elections. As evidence comes to light in hearings across the nation, we have waited expectantly for our elected representatives to join our resolve.

## They have now officially refused.

On December 2, 2020 at 6:30PM MT, Colorado GOP Chair **Ken Buck**, El Paso County Clerk **Chuck Broerman**, Weld County **Clerk Carly Koppes**, and Montrose County Clerk **Tressa Guynes** held a "CaucusRoom" live event with constituents and county clerks across our state.

The purpose of this event was to reassure the people of Colorado that our elections were conducted fairly and without interference. To these Colorado Officials, our response is unequivocal:

Your orchestrated, coordinated, and manipulative narrative intended to gaslight and pacify the people of Colorado is wholly rejected.

The evidence presented with regards to Dominion Voting Systems, in lawsuits and legislative hearings across the country, impacts every single state in which these systems were used. Dominion is used in 61 of 64 counties in Colorado, but all 64 counties have their results aggregated by the Secretary of State's office, using Dominion tools and methods. This week in both Michigan and Georgia we heard witness testimony about Dominion warehouses where "test votes" were printed with no chain of custody. The official results website for our state is copyrighted by Scytl.us, where election related servers were reportedly seized in November.

Further, there is pending litigation in our state with regards to voter rolls and for good reason. (Judicial Watch et al. v. Jena Griswold, Colorado Secretary of State and State of Colorado; No. 1:20-cv-02992). There is evidence of deceased citizens and non-residents voting in Colorado. One resident went to the lengths of cancelling his registration and destroying the mail in ballots received at his parents' house in Colorado after he moved to North Carolina. Even with those precautions, "he" still voted in Colorado in the 2020 election.

## This didn't just happen once.

Secretary of State Jena Griswold has defamed Judicial Watch's valid legal effort to reconcile our Colorado voting rolls. Shockingly, this attempt to discredit the very real voter roll issues and evidence was fully co-signed by leadership in the Colorado GOP on Wednesday night. We can now only assume that you agree with Mrs. Griswold's effort to maintain the corruption in the status quo.

We will no longer stand for centralized manipulation and "oversight" of our election processes, procedures and systems in Colorado. Clean voting rolls are critical to election integrity. Chain of custody and accuracy of the audit logs are critical to election integrity. System reliability is critical to election integrity. Public trust is critical to election integrity.

We are a growing organization of concerned Patriots with vast expertise, resources, and an extensive network. We will not allow for this coordinated, inter-state conspiracy to defraud the American People to go uninvestigated, litigated and punished.

And we consider Denver, Colorado, the US Headquarters of Dominion Voting Systems, to be Ground Zero. We demand our elected officials take action to prevent the fraudulent certification of the fraudulent vote in Colorado.
